Tax Collections at FMUB

New this year, you will be able to pay your property tax bills at both locations of Farmers & Merchant's Union Bank in Columbus. These payments will be accepted during regular business hours.

* Make sure to bring your tax bill to ensure proper payment.

*Please note, if you have an escrow or other check that is greater than the balance of your tax bill, I will mail you your refund check after the next board meeting. The bank will NOT be issuing refunds.

Land Notification in Dodge County!

What is Land Notification? The Land Notification system gives you the ability to monitor a name or a specific parcel of land for property real estate activity. You can create one or more alerts that are triggered when real estate records for the name or property identified in the alert are recorded within the Dodge County Register of Deeds office.

When an alert is triggered, an email will be sent to the email address provided in the alert. The email will contain more information about the activity and will have a link to LandShark, our county on-line property records system.

DID YOU RECEIVE YOUR LOTTERY & GAMING CREDIT??

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible.

To Qualify: You must own a home in Wisconsin
Your home must have been occupied as a
PRIMARY resident on January 1, 2014.

- a. A primary residence is the home in which a property owner lives for more than six months of the year.
- b. If temporarily away, a primary residence is the home to which the owner returns.

If you feel you qualify for the credit, and there is not a lottery credit on your tax bill, please plan to come to the Town Hall on one of the collection days to get the adjustment made.
