# DID YOU RECEIVE LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible.

**To Qualify:** You must own a home in Wisconsin, you must have occupied the home and be the PRIMARY resident on January 1, 2022.

- a. A primary residence is the home in which a property owner lives for more than six months of the year.
- b. If temporarily away, a primary residence is the home to which the owner returns.

If you feel you qualify for the credit, and there is not a lottery credit on your tax bill, please plan to come to the Town Hall on one of the collection days to get the adjustment made.
